(i) 備用第一按揭貸款(「第一按揭貸款」) Standby First Mortgage Loan ("First Mortgage Loan")

(ii) 買方可向賣方指定財務機構申請第一按揭貸款。主要條款如下:

The Purchaser can apply the First Mortgage Loan from the Vendor's designated financing company. Key terms are as follows:

(1) 買方必須於買賣合約內訂明的付清成交金額餘額之日或發展項目的預計關鍵日期(以較早者為準)前最少 60 日以書面向指定財務機構申請第一按揭貸款。

Only interest payment of the First Mortgage Loan is required and no repayment of the principal of the First Mortgage Loan is required for the first 2 years.

The monthly instalment and interest shall be accrued starting from the third year.

- (8) 買方及其擔保人(如有)須提供足夠文件證明其還款能力，包括但不限於在指定財務機構要求下提供信貸報告、收入證明及/或銀行紀錄。

The Purchaser and his/her/its guarantor (if any) shall provide sufficient documents to prove his/her/its repayment ability, including without limitation the provision of credit report, income proof and/or banking record upon request by the designated financing company.

- (9) 第一按揭貸款申請須由指定財務機構獨立審批。

The First Mortgage Loan shall be approved by the designated financing company independently.

- (10) 所有第一按揭貸款法律文件須由賣方或該指定財務公司指定之律師行辦理，並由買方負責有關律師費用及雜費。買方可選擇另行自聘律師作為買方代表律師，在此情況下，買方亦須負責其代表律師有關第一按揭貸款的律師費用及雜費。

All legal documents of the First Mortgage Loan shall be prepared and handled by the solicitors designated by the Vendor or the designated financing company. The Purchaser can choose to instruct his/her/its own solicitors to act for him/her/it, and in such event, the Purchaser shall also bear his/her/its own solicitors' costs and disbursements relating to the First Mortgage Loan.

- (11) 買方敬請向指定財務機構查詢有關第一按揭貸款用途及詳情。第一按揭貸款批出與否及其條款，指定財務機構有最終決定權。不論第一按揭貸款獲批與否，買方仍須按買賣合約完成住宅物業的交易及繳付住宅物業的成交金額全數。

The Purchaser is advised to enquire with the designated financing company about the purpose and the details of the First Mortgage Loan. The approval or disapproval of the First Mortgage Loan and the terms thereof are subject to the final decision of the designated financing company. Irrespective of whether the First Mortgage Loan is granted or not, the Purchaser shall complete the purchase of the residential property and shall pay the full Transaction Price of the residential property in accordance with the Agreement for Sale and Purchase.

- (12) 第一按揭貸款受其他條款及細則約束。

The First Mortgage Loan is subject to other terms and conditions.

- (iii) 賣方無給予或視之為已給予任何就第一按揭貸款之批核的陳述或保證。

No representation or warranty is given or shall be deemed to have been given by the Vendor as to the approval of the First Mortgage Loan.

- (iv) 賣方沒有參與及提供第一按揭貸款。第一按揭貸款只是由指定財務機構提供予買方。而無論在任何情況下，賣方無須因第一按揭貸款所引發的任何事情負上任何責任。

The Vendor is not involved in the arrangement of the First Mortgage Loan. The arrangement of the First Mortgage Loan is provided or procured to the Purchaser by the designated financing company and in no circumstances shall the Vendor be held liable for anything arising from or in connection with the

arrangement of the First Mortgage Loan.

- (h) 「1房限時優惠」：凡於 2021 年 2 月 1 日當日或之前簽署臨時買賣合約之買方可獲額外 1% 售價折扣優惠。

“1-Bed Room Limited Time” Discount: Where the preliminary agreement for sale and purchase is signed on or before 1 February 2021, an extra 1% discount from the Price would be offered to the Purchasers.

- (i) 「C 單位限時優惠」：凡於 2021 年 2 月 1 日當日或之前簽署臨時買賣合約之買方可獲額外 1% 售價折扣優惠。只適用於以下指明住宅物業：3C、6C、11C、15C、17C、19C、20C、23C

“Unit C Limited Time” Discount: Where the preliminary agreement for sale and purchase is signed on or before 1 February 2021, an extra 1% discount from the Price would be offered to the Purchasers. Only applicable to the following Specific Residential Properties: 3C、6C、11C、15C、17C、19C、20C、23C

- (j) **第一按揭貸款 First Mortgage Loan**

買方可申請第一按揭貸款，該第一按揭貸款主要條款如第(7)(g)段所述（經必要的變通後）者。

The Purchaser may apply for a First Mortgage Loan, the key terms of which shall be as set out in paragraph 7(g) above, mutatis mutandis.

- (k) 「新春限時優惠」：凡於 2021 年 2 月 22 日當日或之前簽署臨時買賣合約之買方可獲額外 1% 售價折扣優惠。

“Chinese New Year Limited Time” Discount: Where the preliminary agreement for sale and purchase is signed on or before 22 February 2021, an extra 1% discount from the Price would be offered to the Purchasers.

- (l) 「新春限時優惠」：凡於 2021 年 3 月 22 日當日或之前簽署臨時買賣合約之買方可獲額外 1% 售價折扣優惠。

“Chinese New Year Limited Time” Discount: Where the preliminary agreement for sale and purchase is signed on or before 22 March 2021, an extra 1% discount from the Price would be offered to the Purchasers.

- (m) 「印花稅津貼」優惠：買方可獲額外 5% 售價折扣優惠作為「印花稅津貼」優惠。

"Subsidy of Stamp Duty" Benefit: An extra 5% discount from the Price would be offered to the Purchasers as "Subsidy of Stamp Duty" Benefit.

"Early Spring Limited Time" Discount: Where the preliminary agreement for sale and purchase is signed on or before 21 March 2022, an extra 1% discount from the Price would be offered to the Purchasers.

- (y) 「復活節限時優惠」：凡於 2022 年 4 月 25 日當日或之前簽署臨時買賣合約之買方可獲額外 1% 售價折扣優惠。

"Easter Limited Time" Discount: Where the preliminary agreement for sale and purchase is signed on or before 25 April 2022, an extra 1% discount from the Price would be offered to the Purchasers.

- (z) 「夏日限時優惠」：凡於 2022 年 8 月 31 日當日或之前簽署臨時買賣合約之買方可獲額外 1% 售價折扣優惠。

"Summer Limited Time" Discount: Where the preliminary agreement for sale and purchase is signed on or before 31 August 2022, an extra 1% discount from the Price would be offered to the Purchasers.
